PLEASE READ ENTIRE FORM BEFORE COMPLETION

Steps to receive Open Door Price:

1) On the scale, locate your income level and number of dependants in your household. The price that appears in the box is your automatic, guaranteed price.

2) Send in a copy of your 1040 Tax Form, a Camp Registration Form and \$100 deposit to the YMCA of Saginaw. You will receive a call and/or an email to confirm your registration and price.
